We have now considered these reasons and now fully agree with BCBCs Planning Department in coming to those conclusions. The revised application P/22/92/FUL does not appear to have addressed the main reasons for previous refusal; namely, the height of the decking and related structures dominating the residential amenity and privacy of the neighbouring properties on either side of the site in question. It would appear the only revision has been a change of siting for steps from the decking; some roof alterations to the pergola; and some shrub planting.</p>

	<p>The height of the decking has not been addressed which is the main problem.</p> <p>From those observations, it would appear that the basic problems of height have not been addressed in this revised application. So, on balance, we must lodge an objection to these proposals which remain detrimental to amenities of neighbouring properties.</p>
