**Objection** on the grounds of Highway Safety & Design/ appearance. A digital, rotating advertising screen could be a distraction to drivers at this busy junction. There are currently no rotating digital advertising boards in this area and it is not in keeping with the character of the area.

**10: Planning Reports/Correspondence (if any).**

**a. Air pollution on Park St (Cllr T Wood)**

- Cllr T Wood noted that the completion date for the monitoring of air pollution in this area is the summer of 2021 and asked the Chair if any updates have been received. He explained that there are currently 3 new housing developments in the area yet to be completed that would have an impact on air pollution and suggested that the monitoring should be extended.
- The Chair informed Cllr T Wood that he had submitted a Freedom of Information request to the Vale of Glamorgan Council and was expecting a written response this week which he would circulate to Members.

**b. Bryn Castell housing development, Cefn Glas (Cllr T Wood)**

- Cllr T Wood informed Members of his concern that a number of trees were being cut down at this development. The Chair confirmed that he would investigate the matter to ensure that planning conditions were being adhered to.

**c. Coed Parc housing development, Park St (Cllr T Wood)**

- Cllr T Wood reported that building had started on this development. The Chair informed Members that he would inspect the site to ensure that planning conditions were being adhered to.
- Cllr T Wood thanked The Chair for his assistance and support with all above matters.
