## Re: Bridgend Local Access Forum

I refer to my letter of 22<sup>nd</sup> July 2022 regarding the election of a person to represent the Town and Community Councils on the Bridgend Local Access Forum.

As you will recall from that letter each Town and Community Council was asked to decide whether they wished to nominate a person to take part in the election to become the Town and Community Council's representative on the above Forum. You will also recall that each nominee was asked to complete an application form indicating why he or she felt they would make a good member.

Following the closing date for receipt of nominations I can confirm that the County Borough Council has received 5 nominations. The persons nominated are identified on the attached ballot paper and a copy of each of their statements is attached. Please note that there is no application form Community Councillor J Coles of Garw Valley Community Council or Town Councillor J Pratt of Porthcawl Town Council.

In accordance with the procedures previously identified each Town and Community Council must now vote for the person they believe will be best able to represent them on the Forum. The Council is operating a single transferable voting system therefore your Council is requested to rank the nominees in order of preference up to a maximum of 1 to 5 **where 1 is your Council's preferred person and 5 is its least preferred person.**

I should be grateful, therefore, if your Council would consider all the information provided by the nominees (where applicable) at their next meeting and decide how they wish to vote. The ballot paper should then either be returned to the Rights of Way section at the County Borough Council by the 3<sup>rd</sup> March 2023.


