There seems to be no grounds for felling at the present time other than in speculative preparation for a further housing planning application which may, or not, be granted in the future. These are not sufficient grounds for granting and are premature.</li> <li>b. There is doubt that every tree on any proposed development site is in such poor condition as to warrant destruction at this time. An independent survey is required.</li> <li>c. The removal of all the trees in the location would leave a serious gap in the street scene along the A4063 to the detriment of established dwellers opposite the site and decimate the outlook.</li> <li>d. The current national ecological strategy is to preserve the growing environment wherever possible, and trees of whatever maturity and condition aid the absorption of carbon dioxide emitted from passing traffic on the A4063 which is a major route into Bridgend.</li> <li>e. BTC reserves the right to attend any site meeting that may be called, and</li> </ol>
